Reasoning

As a part of re-structuring and coordinating the internally running educational quality assurance and accreditation-related processes across the whole ITU community, a series of a "*Knowledge Sharing Meetings*" were initiated at the beginning of 2015 by the HBA and the ODoS; the latter two acting as the leading units of the university on the subject matter. Accordingly, and with the support of the HBA, the ITU-ODoS organized, conducted, and moderated a total of 9 meetings between Feb 2015 and June 2016, primarily with the participation of the ITU-ABET Institutional Representatives [IRs] (Departments' Chairs [Primary Contact Persons] and Departments' ABET Accreditation Coordinators [Pre-visit Contact Persons]—BBABKo), and in some cases with the addition of the Deans and Vice Deans (Figure D-6). Main objectives of those meetings were:

- (i) university-wide coordination of the educational quality assurance practices and preparatory works for ABET EAC re-accreditation,
- (ii) harmonization of the related processes and procedures,
- (iii) mediating interactive discussions and collaborative decision-making, and,
- (iv) knowledge sharing on educational quality assurance & accreditation-related matters.

ITU "NINOVA – ABET" On-Line Knowledge Sharing and Deposit System was used as the media for announcements of and invitation to the meetings, and for depositing the presentations and minutes from the meetings.

Schedule and Content

Schedule of the "ITU-ABET Institutional Representatives (IRs-[BBABKo]) Knowledge Sharing Meetings" organized by the ITU-ODoS is marked on the flow-chart given below in Figure D-7, where ITU's "Strategic Plan" and the "Time-Line of the Preparatory Works" for re-accreditation of its 23 and initial accreditation of its 2 UPs during the 2016-2017 ABET EAC Review Cycle are presented. Main themes, detailed agendas, and dates of the "Knowledge Sharing Meetings" series, as well as the participants and participation percentages are summarized in Table D-9.
